The State Historic Preservation Division (SHPD) has been notified of community concerns regarding work being conducted under Permit No. 786353 at the subject parcel TMK (1) 3-6-023:006. The Department of Planning and Permitting (DPP) issued the permit on May 6, 2016. The SHPD was notified of concerns via email on April 10, 2018. Specifically, the community is concerned that the subject project may impact human burials present within lava tubes either on or near the property. Furthermore, the SHPD received notification that the Office of Hawaiian Affairs (OHA) also has concerns regarding the presence of possible burial sites and the ongoing work (April 11, 2018; HRD 18-8515).

Our records show the community also opposed the proposed development for a cluster housing permit application (No. 2006/CL-10) at 5203 Keikilani Circle and 5084 Kiai Place (TMK [1] 3-6-023:006 and 007) and notified DPP in a letter dated October 1, 2006 (Dennis Wachi to Henry Eng, DPP Director). Subsequently, our office requested that the permit application not be issued until an archaeological inventory survey (AIS) was completed (November 8, 2006; Log No. 2006.3666, Doc. No. 0611AJ02). Review of our records does not show that an AIS has been completed for either the previous or current project.

Pursuant to Hawaii Revised Statutes (HRS) §6E-42, any agency or officer of the State shall provide the SHPD the opportunity to review and comment on the effect of a proposed project on historic properties, including burial sites. However, our office did not receive the permit application (A2015-04-0763) and was not provided the opportunity to comment on the project prior to the permit issuance.

The SHPD requests that the DPP issue a Stop Work Order for all work being done at the subject parcel until our office is allowed to review subject project in accordance with HRS 6E-42 and Hawaii Administrative Rules (HAR) §13-284.
